1500.	<p>PRESENTATION BY JULIE MARTYN MID AREA HIGHWAYS MANAGER, AND BRIAN WILLETT, CHELMSFORD DISTRICT MANAGER, FROM THE MID ESSEX AREA OFFICE OF ESSEX COUNTY COUNCIL.</p> <p>The Chairman welcomed Julie Martyn and Brian Willett to the meeting. The Chairman reported that traffic volume and speed in the village were major issues. Only last week there had been an accident resulting in two fatalities. HGV traffic passing through the village was also a problem. Many meetings had been held and suggestions turned down by Chelmsford Borough Council/Essex County Council. The Chairman advised that the signage had been changed and that the gates had been put up. The reduction in volume has not happened since the opening of the new A130. A request for a weight restriction to be put on the B1007 was made to Julie Martyn.</p> <p>The telephone number for reporting problems to Essex County Council is 01245 240000. Julie Martyn explained that within the Mid Essex Area Office there are five teams. These are Development Control, Major Projects and the three Teams covering the Districts of Chelmsford, Braintree and Maldon. She advised that all contracts had been revamped and that RCS had received the new 5 year contract. McAlpine had previously had the contract. Julie Martyn advised that the other contracts are held with Rainsway Construction South, Beech, Bagnall & Morris, who deal with gullies, and Cartledge, who deal with lighting. Julie Martyn advised that Phil Hope would be attending the next Parish Council meeting. She advised that the work on the road stays the same but that the administering had been changed. Phil Hope (Engineer) is the contact for maintenance who reports to John Dobinson the Highway Maintenance Manager. Robin Murray, Principal Engineer is your contact for Traffic and Chris Fox for Overgrown Hedges. Julie Martyn advised that the Council are prioritizing where the money is spent and there is not enough funding. Therefore Essex County Council are concentrating on dangerous defects. Essex County Council aim to respond to complaints within 20 days and each complaint has a risk assessment and category. The priority is safety and faults in the Highway. Cllr. Otter mentioned the map at County Hall indicating that electronic signing was going to be put on the B1007. Julie Martyn was unaware of this.</p> <p>It was reported that the footpath between Stock and Billericay (School Lane and Honeypot Lane) is unsafe if you are trying to cross and a suggestion was made that the footpath be put on the other side as both ends of the footpath are on a bend. Julie Martyn agreed to look into this matter.</p> <p>It was reported that the surface in Downham Road/Leather Bottle Hill was like a sheet of glass and needed retexturing. The white lines need to be taken out to prevent a collision, as the width is not two vehicles wide. Mr Willett agreed to look into the matter. The matter of rat-running was also mentioned in Downham Road, particularly HGV's. An accident had occurred on the 8th July between a car and HGV due to excessive speed and the road being too narrow.</p> <p>Rat-running in Smallgains Lane was mentioned. A speed survey had been requested which had been done. It was reported that the loop had only been there for three days and not for a week. It was reported that a speed restriction was needed in the Lane. The grass verges also need to be reinstated. Mr Willett to look into matters.</p> <p>It was reported that the stumps in Birch Lane are an eyesore and a hazard to pedestrians as they are on the pavement. Mr Willett to look into matter.</p>	

	<p>It was reported that a section of the B1007, approaching the village from Chelmsford, is an unrestricted speed limit and that the Parish Council would like to see the 40mph speed limit extended to cover that area. Julie Martyn advised that there is a speed policy and there are criteria for each level of speed limit. She agreed to look at the matter and check the criteria. She advised that Essex County Council are working with the police on Community Speeding and Speed Watch. Julie Martyn advised that the commitment campaign had just been launched encouraging individuals to stick to the speed limit.</p>	
1501.	<p>NEIGHBOURHOOD POLICING.</p> <p>P.C. Graham Thomas and PCSO Ian Hilton introduced themselves to the Parish Council. PCSO Hilton is partly funded by Writtle Parish Council and therefore 70% of his time is committed to Writtle village. It was reported that to part fund a PCSO costs the Parish Council £15,000.00 a year. It is possible to share the PCSO with another Parish and share the cost. There is another PCSO called John Gibson and another is being employed. The PCSO is in constant contact with the Parish Council and Neighbourhood Watch. The matter of surgeries in the village was discussed and P.C. Thomas advised that the police were trying to get a mobile police station up and running. The Parish Council felt that the surgeries that P.C. Elmer had held in the tearoom had been successful and P.C. Thomas therefore agreed to look into the matter.</p> <p>P.C. Thomas has just come off of the Response Team (999) and prior to that he had been in the Town Unit. He advised that there was now a new style of policing, which was called Neighbourhood Policing. The drug problem and use of syringes on the Common was mentioned. P.C. Thomas advised that he can report problem areas to the traffic police and they can be put on SARA so that the village gets extra attention. The Parish Council reported that visible police presence is needed. The Parish Council agreed to discuss the matter of funding a PCSO at another Parish Council meeting.</p>

1503.	<p>MINUTES OF THE MEETING HELD ON 26TH JUNE 2006.</p> <p>The Minutes of the Meeting, having been previously circulated, were then duly signed as a true record of events. All agreed.</p>	
1504.	<p>VACANCY FOR A PARISH COUNCILLOR.</p> <p>Mr Battley of Chelmsford Borough Council had advised the Clerk that he had received no request that an Election be held to fill the vacancy. The Parish Council are therefore free to fill the vacancy by Co-option. The Clerk had put a notice advertising the position on the noticeboard and website. All applications should be sent to the Clerk by the 11th August 2006 and applicants will then be invited to attend the meeting on the 21st August when the Co-option will take place.</p>	
1505.	<p>MATTERS ARISING FROM THE MINUTES.</p> <p>Tree Warden Scheme – Cllr. Phillips had kindly offered to take on the role of Tree Warden.</p> <p>Noticeboards - Clerk advised that the noticeboards had arrived and had been erected. A letter of complaint had been received from Dennis Lusty who described the new noticeboard at the top of Swan Lane as an obtrusive monstrosity. He advised that the noticeboard is already in use but being abused by the type of notices being erected. The Chairman had replied advising that the Parish Council have been very short of noticeboards for the last couple of years to put up all the notices that need to be displayed. Accordingly the Parish Council felt obliged to put up sizeable boards to resolve this long-standing problem. The Chairman felt that although Mr Lusty felt it is over large, she is sure that in time it will blend into the scenery. It is unfortunate that it is being abused at present but the handyman has been unable to complete putting up the board due to a family bereavement and injury. Cllr. Williams had received some favourable comments regarding the noticeboards.</p> <p>Doctor's Surgery – Chris Robinson of Essex County Council's Highways Department advised the Clerk that he has had discussions with both Dr Acorn, his design consultant and his contractor over a number of months but it was not until 18th July that it became clear that a detailed letter sent by him at the end of March had not apparently been received at the consultants. Mr Robinson's letter contained a number of matters of detail that do need to be resolved before the doctors can implement the obligation to provide the footway. Mr Robinson has today spoken with the consultant who has assured him that the information and details requested in his last letter of 31st March will be with him later this week. Mr Willett of Essex County Council to look into matter.</p>	

Grant from Essex County Council – Cllr. Elliott advised that the Chairman and Vice Chairman of the Village Hall were going to get someone to put the screen up. It was agreed that the Parish Council would pay the bill. Once the screen was up the electrician could come.

Stock United Football Club – Nothing further to report.

Whitening of Zebra Crossing – Cllr. Grundy advised that the zebra crossing had been re-whitened but the poles had not been painted.

Benches for Children’s Play Area – Cllr. Williams to chase Bob Hale regarding the missing plank off the seat. **JW**

Overgrown hedges at the T-junction at the end of Mill Road where it meets Downham Road – Mr Fox was writing again to Mr Nation requesting that he cut his hedge.

Parish Paths Partnership (P3) – Please see item below.

Footpath between Swan Lane and Dakyn Drive – The gates had now been erected.

Black and White Posts on the corner of the right hand bend of Smallgains Lane – Mr Willett of Essex County Council said that he would look into the matter.

Speed Indicator Device – Clerk to chase matter with Mr Murray. **CLERK**

Post outside The Paddocks – The post is still missing.

Dirty Road Signs – Nothing further to report.

Signpost at end of Swan Lane – Andy Nichols has now removed the sign and dismantled it.

Condition of pavement/road surface in Falkner Close – Clerk to chase matter with Highways. **CLERK**

Parish Litter/Refuse Clearing Days 2006 –Operational Hit Squad – Clerk to E-mail Councillors to see who is available to meet Hit Squad on the 20th September. **CLERK**

Footpath sign missing by the pond in Mill Road – Work has been completed.

Summer Play Activities - The Play Day is to be held on Tuesday 8th August.

Green in front of the Almshouses – The Clerk had sent copies of Mr Stringers’ E-mails to Highways to deal with. Clerk to chase matter with Julie Martyn at Essex County Council. **CLERK**

Hedgerow outside Mrs Raeburn’s house in Birch Lane – Clerk had written to Mrs Raeburn who had said that the hedges were not on her land. Clerk had contacted Mr Fox at Chelmsford Borough Council who was going to look at Council maps and take a look at the hedges in question. Cllr. Grundy agreed to speak to Anthony Raeburn about the matter. **IG**

Brickwork Crumbling on a Surface Water Drainage Pipe at the Entrance to the Pond in Mill Road – Clerk to chase matter with Highways. **CLERK**

Dead tree by the ditch on the Common on the right by the bend – Cllr. Watling to remove. Cllr. Otter reported that there are tree stumps that need to be professionally drilled out and replanted. Cllr. Phillips to look at. **RW**

Dead tree laying down covered in ivy by Boundary House – Cllr. Watling to look at. **RW**

Syringe found on the Common – The Clerk had contacted P.C. Thomas who was going to put out an alert to all patrol cars and arrange for extra cars to visit the village.

Missing Street Sign at the top of Well Lane – Clerk had arranged with Jane Howard of Chelmsford Borough Council for a replacement sign which would take up to 6 weeks to complete.

A Boards Outside Pubs in the Village - No reply received to-date. Clerk to chase matter with Mr Bohannan. **CLERK**

	<p>Footpath 13, Swan Lane – Tim Gardiner had looked at Footpath 13 that runs from Fristling Hall to the back of Tye Green Cottages on Swan Lane. It seems that the path is not obstructed by a barbed wire fence as Dennis Lusty suggests (although there are barbed wire fences near the path) but is very overgrown by brambles and nettles in one place that prevents walkers from getting through as there is fence on either side. The path is also not waymarked in three places so could benefit from the installation of signposts, which could help sort out the confusion to the walker. The jobs to be undertaken could be done by a small work party of volunteers to clear the vegetation with hand tools and put the waymark posts in – P3 would supply the posts and waymark discs. The Chairman had spoken to John Surgenor who had agreed to be the P3 representative for the village. 4th October had been the date set to carry out the work. Mr Surgenor had agreed to attend the first aid course and risk assessment course in November. The Clerk had checked with Zurich regarding insurance and the Parish Council are covered for £5 million Public Liability Insurance. It was agreed that the Parish Council should advertise for volunteers to help on the 4th October to clear the footpath.</p> <p>Pond in Mill Road – Mr Williams of Blackwater Landscapes had asked to carry out pond maintenance once a month during the Spring and Summer as the pond requires more attention. The build up of duckweed on the pond appears to be becoming a problem. Mr Williams is trying to clear the pond as much as he can using a net but the use of chemicals would do a much more thorough job and would in no way harm any of the flora or fauna within the pond, they are designed not to. Cllr. Johnson had spoken to Mr Williams and had agreed that he could carry out the work. Cllr. Johnson stated that Mr Williams had done a very good job and that the debris had been left on the side because it was too heavy but it will be removed in due course. Cllr. Johnson advised that the chemical Mr Williams had suggested using had been taken off of the shelf and that there were no other chemicals which could be used to deal with the duckweed. Mr Williams had therefore cleaned the pond with a large net. It was agreed that Mr Williams could carry out the work once a month. Jackie Lane is going to contact Cllr. Johnson when she returns from holiday.</p> <p>Parish Sports Programme - Cllr. Tully advised that building work was being carried out at the school so the event could not be held this year.</p> <p>Big Lottery Fund: Planning for Play Programme and Chelmsford’s Play Strategy Meeting – Cllr. Phillips had attended the meeting. Cllr. Phillips reported that David Archer, Play Services Manager, at Chelmsford Borough Council had allocated £285,666.10 to 27 parishes to provide facilities free of charge to children but the children have to be involved in the decisions. Mr Archer needed applications by 1st September and needed to know what there was a desperate need for in play facilities in the village and what facilities there are and are not in the village. It was decided that this was not a feasible idea to do in the timeframe. The Chairman thanked Cllr. Phillips for attending the meeting.</p>	<p>SE</p> <p>CLERK/SJ</p>
<p>1506.</p>	<p>GENERAL CORRESPONDENCE.</p> <p>The following letters were read out:-</p> <ul style="list-style-type: none"> a) Mr James Webb regarding the pavement opposite All Saints Church leading to the village being taken up by Church Green Cottages’ roadside hedge. It was agreed that the Clerk should write to Beryl Woodward and Mr Thomasin-Forster asking them to cut the hedges. b) Mr Williams of Blackwater Landscapes had written about the new advertising board outside The Baker’s Arms on the grass verge along the High Street. The new sign seems to be made out of cast iron and weighs a tonne. One of Mr Williams’ colleagues nearly put her back out trying to move it. The Clerk had written to Mr Southgate, the owner of the Bakers Arms, enclosing a copy of Mr Williams’ letter pointing out the difficulties that the grass cutters were having and asking him to put the sign in a place that does not cause a problem for the grass cutters. The Clerk had given Mr Southgate Mr Williams’ telephone number. Cllr. Otter said that the sign obstructs the vision as you turn out of Common Lane and that it should be moved out of the sightline. c) Nick Peacock advising that the litter bin in Swan Lane (opposite Swan Woods) needs repairing or replacing. Clerk to order new bin and have it delivered to Cllr. Elliott who would arrange to obtain a quotation for erecting the bin. d) Mr Cribb of Harvard House East, High Street, regarding the zebra crossing ‘flashing light’ illuminating into his lounge and asking for the procedure in having a guard installed around the light. The Clerk had contacted Julie Martyn at Highways who was sending someone from the Street Lighting team to investigate. 	<p>CLERK</p> <p>CLERK</p>

	<p>e) Tim Coleman regarding the speed people travel through Leather Bottle Hill and pointing out the amount of accidents that have occurred in the past couple of weeks. The Clerk had sent a copy of the E-mail to P.C. Davey and Julie Martyn at Essex County Council Highways Department. A reply had been received from P.C. Adam Pipe advising that the high number of collisions had been at the junction with the main B1007 but very few, if any, reported injury collisions on Downham Road and Leatherbottle Hill. About three years ago the police met with local residents and representatives of the Highway Authority. Various ideas were put forward including a reduction to the existing de-restricted speed limit. However, it was decided that a lowering of the limit would be seen by most drivers as inappropriate due to the nature of the road and a lack of visible properties which would in turn give them a real enforcement problem. A decision was made to enhance the community of Leather Bottle Hill by erecting signs giving Leatherbottle Hill an identity in an effort to adapt drivers' behaviour through the location. P.C. Pipe felt that the main concern for locals is not actually vehicle speed but volume as the two often get confused. It is highly unlikely that the Highway Authority will take any additional action on the route as there has been too few reported injury collisions. However, P.C. Pipe will raise at the next Police Liaison Meeting as a priority neighbourhood concern. Mr Willett had agreed to arrange for the road to be retextured and to have the white lines removed.</p> <p>f) Gary Stringer regarding Bishop of Brentwood's letter to the Parish Council last month suggesting that rumble strips be installed. Mr Stringer enclosed a copy of the letter that he had sent to Julie Martyn in Essex County Council Highways Department. Whilst Mr Stringer supports the need to slow the traffic, the method has to be chosen carefully to ensure the situation is not made worse for those close to the road. Mr Stringer feels that rumble strips may be a solution that suits those set back from the road or living elsewhere in the village but would be a horrific solution to his family as they live just a few metres from the road.</p> <p>g) The Chairman had been contacted by Jack Lord, a researcher, from the BBC regarding research on traffic problems in the village. Mr Lord is putting together a new television series called One Show, which will be a half hour factual programme of things of local interest in East Anglia. For example, villages being blighted by traffic. The Chairman had discussed the history of Stock and the protests etc with Mr Lord. Mr Lord had asked for photographs, which Cllr. Watling had provided him with.</p> <p>h) John Surgenor advising that the Tarmac Footpath between Swan Lane and Dakyn Drive needs attention. There is a big shrub and other shrubbery obstructing the path and it would appear that some, if not all, is growing through from the bungalow adjacent. It was agreed that the bungalow in question was 13 Swan Lane owned by Mr and Mrs Underwood. Clerk to contact Chelmer Housing.</p>	CLERK

Bakers Arms Car Park – Mr Southgate did submit an alternative plan (but not a planning application) for the replacement car parking spaces, this was considered by the Planning Officer and been refused. Following that, Mr Bohannon has requested that Mr Southgate now goes ahead with the tarmac of the area as he seems to have exhausted all his alternatives. If Mr Southgate now fails to do this the Enforcement Team will issue a Breach of Condition Notice and resolve the matter that way.

<p>1512.</p>	<p>ESSEX RURAL HOUSING TRUST.</p> <p>Anne Bishop had advised the Clerk that following the Village Information Day, Essex Rural Housing Trust have tweaked the proposed layout a little so that there is not so much parking in the area next door to the neighbouring house. They have also had a traffic census carried out which has shown that the proposed scheme would have minimal effect on the junction of Back Lane/High Street. This means that the Trust can progress towards submitting the planning application hopefully in August, possibly in September. Anne Bishop will let the Clerk know when the application is put in.</p> <p>As regards Chelmsford Borough Council deciding that no affordable housing was required in Stock when the development was approved of the Beecham site. The following information has been received by Chelmsford Borough Council’s Housing Department.</p> <p>“I believe that Havard Grange referred to by the PC is a development consisting of 21 large detached dwellings built on the former SmithKline Beecham Research Complex located to the south west of the village off Honeypot Lane / Ingatestone Road. A planning application for approval of reserved matters relating to the erection of 17 detached dwellings and related development was presented to Planning Committee in Jan 03 (02/01593/REM) where members authorised the Head of Town Planning Services to approve the application subject to a s106 Agt. This S106 was subsequently completed and a decision notice issued in June 03. A financial contribution to a RSL by way of a planning obligation was sought in lieu of the provision of affordable housing within the development as agreed at time of outline application. Subsequently 6 x properties were purchased throughout the borough with this contribution.</p> <p>At the time of outline application (97/01410/OUT Dec 98) the applicant company did not consider this site as an acceptable location for affordable housing as the applicant felt it was relatively isolated from schools and other facilities. In addition the applicant considered the low density as being appropriate to the site and the inappropriateness for affordable housing as envisaged in CBLP Policy HO2ii. CBC planning and housing officers remained of the view that policy HO2 CBLP was of relevance to the site and that it would <u>not</u> be inappropriate to seek affordable housing provision on site. Although officers considered the site suitable in location terms for affordable housing, on the basis of para 22of Circ 6/98 set out below, officers were prepared to consider provision elsewhere by way of commuted sum payment providing this would be sufficient to actually purchase a site to enable 6 x family homes to be built and be situated where access to services is available. A recommendation was made to Environment Committee that application be refused for various reasons including the absence of proposals for onsite provision or an agreed commuted sum in lieu thereof, the Committee resolved that planning application be refused. An appeal was lodged and a Public Inquiry was held in July 99. The appeal was allowed by the Inspector in Sept 99. (These discussions predated the Housing Needs Survey carried out in July 2002)</p> <p><i>Circ 6/98 '22. However, if the local planning authority and the developer both consider that, on particular sites where a requirement for an element of affordable housing would be appropriate, it is nonetheless preferable that a financial or other contribution should be made towards the provision of the element of of affordable housing on another site in the Local Planning Authority's area, they should ensure that such arrangements would actually result in the provision of affordable housing (whether via new build or conversions), that would not be otherwise provided, in the local planning authorities area. These arrangements should not be used in respect of application sites which are inherently unsuitable for the provision of an element of affordable housing, such as those below the site threshold and other criteria set out in paragraph 10 above.'</i></p> <p>No doubt you are aware that Chelmsford Borough Council will only consider off site provisional in exceptional circumstances and when an alternative site has been identified that would enable a more appropriate output that could not be achieved through on-site provision”.</p> <p>It was agreed that the Clerk should write back to Anne Bishop stating that the Parish Council understood that any planning application was going to be submitted jointly with the Parish Council and that if the Parish Council did not support the application then the Rural Housing Trust would withdraw it. The Parish Council are surprised to hear that the application is being submitted in August/September without the Parish Council’s input.
