| | <p><u>Applications.</u></p> <p>Application No. 08/01671/FUL. Demolition of existing dwelling and erection of 2 no. detached dwellings, garages and cart lodge. Location: 87 Mill Road, Stock. Applicant: Jenny Moody Properties Ltd (Mr S Wheelhouse). The Parish Council objected to this application and commented that the area is characterised by hedges and vegetation with properties discreet from the road. The overall character is rural. The houses are completely out of character with the street scene. The overall height and bulk of these houses will obscure a view of the windmill which is an important historical building and landmark.</p> <p>Application No. 08/01648/FUL. Single storey rear extension. Location: 11 Hereward Mount, Stock. Applicant: Mr I Drury. The Parish Council had no comments or objections to make.</p> <p>Application No. 08/01665/FUL. Part single, part two storey rear and side extension. Location: Plantation Cottage West, Mill Road, Stock. Applicant: Mr & Mrs R Nunn. The Parish Council commented that this should comply with Green Belt policy. The proposed extension is large in proportion to the existing property.</p> <p><u>Applications for Works to be carried out on trees in Conservation Area and trees that have Tree Preservation Orders.</u></p> <p>Application No. 08/05182/TPO. T1 - Oak in front garden - 20% crown reduction and crown thin, clean out dead wood (TPO/1989/035). Location: 10 Birch Lane, Stock. Applicant: Mrs H Phillips. Approved.</p> <p>Application No. 08/05188/TPO. A1 – Lime x 1 in front garden – fell to ground and grind stump; A1 – Lime x 2 in front garden – remove epicormic growth up to 2m as necessary for five years. Location: 3 Hereward Mount, Stock.
