1.	APOLOGIES FOR ABSENCE. Cllrs. Rilstone, Finch and CBC Cllr. Grundy sent their apologies.	
2.	MINUTES OF MEETING HELD ON 20TH APRIL 2009. The Minutes of the Meeting, having been previously circulated, were then duly signed as a true record of events. All agreed.	
3.	DECLARING ANY PERSONAL OR PREJUDICIAL INTERESTS. No declarations were made.	
4.	POTENTIAL LAND FOR SPORTSFIELD. Cllr. Woodward advised that a meeting had yet to be arranged with Mr Berkley and that he would contact Savills to get an update on the land on the B1007.	PW
5.	PLANNING MATTERS. <u>Planning Appeals and Decisions.</u> Temple Farm Inquiry – The Planning Inspectorate had notified the Clerk that a meeting would be held on the 1 st June 2009 to find out what has been established in relation to the land included in the proposed development which is now thought to be common land. If the land is not common land the appeal can continue as planned on the 1 st September at 10.00am. If it is common land the Planning Inspectorate needs to know how the Applicant's propose to deal with it. <u>Tree Preservation Orders.</u> Tree Preservation Order No. TPO/2009/013 at Land South West of 56 Well Lane – A Tree Preservation Order was made on the 2 nd May 2009. The reason for the Order is to protect the woodland adjacent to Well Lane, some of which has already been cleared. The trees provide amenity to the rural aspect of Well Lane and a wildlife corridor adjacent and behind residential properties. The loss of these trees is detrimental to the locality and it is for these reasons that an Order is considered expedient to prevent the premature felling of all the trees. <u>Planning Correspondence.</u> The Clerk read out an E-mail that had been received from Cllr. Rilstone who stated that he was concerned that, if the Parish Council decide not to continue with 'Planning Meetings' the 'Main Meeting' will become even more lengthy and onerous than at present. By some mysterious quirk, it seems that the major planning discussions always 'come up' at the 'Main Meeting' leaving rather little to do at the 'Planning Meeting.'	

<p>Cllr. Rilstone suggested that the present 'Planning Meeting' - which is a properly convened meeting - should be expanded to include on the Agenda matters which are at present on the 'Main Meeting' agenda - e.g. The Borough Councillor's Report or Police Matters - thereby rationalising the length of both meetings. The Clerk had advised Cllr. Rilstone that only planning matters can be discussed at a planning meeting.
