Diversion of Footpath 26 at Scriveners Farm

The Clerk had submitted the Parish Council's comments to Birkett Long Solicitors.

48 Well Lane

The Clerk had contacted Paul Bohannan at CBC who advised that on one of his compliance visits he did measure the height of the house up to soffit on the southern side and this complied with the approved plans at 5.3 metres and as such he considered that the height was ok. He has not measured the height of the neighbouring building and as such cannot confirm if there is a discrepancy in the drawing of the street scene. The Clerk had therefore written back asking him to check the dimensions and confirm that he is happy that the new build overall height conforms to the drawings submitted and approved.

Application No. 09/01759/DEM. Demolition of a detached house.

Location: 132 Mill Road, Stock.

Applicant: Mr Bill Wright.

The Planning Officer had advised that the application for prior approval for the demolition of the building was registered and made valid at face value. However, having now investigated the situation at officer level you are advised that the proposal does not require prior approval. The demolition of this building has already been approved under planning application 07/00320/FUL and therefore a separate consent is not required. No further action will be taken with this application and therefore I would be grateful if you could remove the item from your agenda. It was agreed that the Clerk should ask CBC to write to the developer asking them to protect the greensward outside the property.

Application No. 09/01739/FUL. Two storey side extension and rear single storey conservatory with internal alterations.

Location: 3 Lilystone Close, Stock.

Applicant: Mr and Mrs M. Threadgold.

The Parish Council commented that this building is the end of a terrace of character cottages. The architectural style of the proposed development and windows design should be in keeping with the style of the existing building. The cottages were formerly linked with Lilystone Hall which is a listed building and we need to ensure that the listing of Lilystone Hall has no linkage to these character cottages..
